To permanently remove any diving board if it exists prior to the installation of this liner. 2. To relocate any sliding board if necessary, prior to installation of this liner. 3. To defend, indemnify and hold Hydra Pools and its distributors and dealers harmless from any claims by anyone arising from injuries that may occur from the use of the pool containing this liner; 4. To prohibit those using the pool from head-first diving or sliding into the pool, and 5. In addition to abiding by the conditions above, pool owner will not allow use of the pool by unsupervised minors, persons who might be impaired, or anyone, including guests, which is inconsistent with this warning.
